RE: Provision of Accommodations for Individuals with Disabilities During the COVID-19 Emergency

Local health departments (LHDs) in Nebraska are committed to facilitating universal access to public health services. During the COVID-19 pandemic, rural and urban LHDs have ensured that the COVID-19 vaccines are available to Nebraskans who have a condition of body or mind that prevents them from getting to—or otherwise being able to access—a vaccination site near them. LHDs will continue to provide and/or facilitate reasonable accommodations until the public health emergency ends. Examples of how different LHDs have made the COVID-19 vaccine accessible include:

- Partnering with transportation providers to offer rides to accessible clinic sites.
- Proactively phoning identified disabled individuals to provide information and verify their access to the vaccine.
- Providing escorts at mass vaccination sites, for people with limited vision.
- Providing in-home vaccinations to homebound people in some cases at the request of individuals or their families; in other cases, working with social service agencies, healthcare providers (including Visiting Nurses), and/or rural Emergency Managers to identify homebound individuals.
- Providing interpretation, including American Sign Language, at vaccination events.
- Providing vaccination information in multiple languages (written, over radio and video media)
- Promoting and providing vaccinations in locations where individuals with disabilities congregate and/or live including group residential facilities.
- Providing wheelchairs, wheelchair accessibility, parking assistance, drive up services and other accommodations for people with limited mobility.
- Reaching out to groups that serve and/or advocate for disabled individuals to enlist their support in publicizing vaccination opportunities and connecting people who need more help to their local health department.
- Working with pharmacies to provide vaccine to Developmental Disability Organizations (DDOs).

These examples are not an exhaustive list, but underscore LHD's commitment to making the vaccine accessible to *anyone* who wants it. Nebraskans who need accommodations to get vaccinated can contact their local health department directly at the number on the next page.
